

**8m / 10m DOUBLE WATERSLIDE:
TO BE USED AT HIRER'S OWN RISK**

1. A Responsible ADULT 18 years or older to be strictly present at all times when waterslide is used for children's safety. Especially because of the water in the pond area.
2. NO ONE MUST BE IN THE POND AREA WHEN SOMEONE IS ABOUT TO GO DOWN THE WATERSLIDE – SO AS TO AVOID INJURIES.
3. NO ADULTS MUST GO DOWN THE WATERSLIDE WITH CHILDREN. CHILDREN OF THE SAME AGE AND BUILT CAN USE THE WATERSLIDE OR IF ADULTS WANT TO USE THE WATERSLIDE THEY CAN ONLY GO WITH ADULTS AND NOT WITH CHILDREN.
4. NO CHILDREN YOUNGER THAN 5 YEARS MUST USE THE WATERSLIDE FOR SAFETY REASONS.
5. **All equipment, Waterslide to be used at OWN RISK OF THE HIRER/RESPONSIBLE PERSON OR PERSONS ON THE WATERSLIDE.**
6. NO Small children with older and bigger children on Wave slide as bigger children can hurt smaller children that is at the bottom pool end.
7. No children to play with the motor or electricity cable/fitting.
8. Must be set up on GRASS.
9. Only two children can go down at same time.
10. No rocks or hard objects under pond area as this could hurt children as they land into the pond area.
11. All supplied pins must be used on both sides of the waterslide to anchor it. First pump up the waterslide then anchor it so as not to tear waterslide.
12. Before waterslide is deflated or power failure all persons must immediately get off to prevent being entangled in the waterslide.
13. Once waterslide has been deflated no persons to play on deflated waterslide
14. MAXIMUM WEIGHT of persons using wave slide is 75KG.
15. ONLY BUBBLE BATH TO BE USED AND DILUTE IT.
16. Motor must not get wet. Children to be careful when going past motor that it does not get wet. Place a chair over motor. Also please put motor inside if it rains.
17. PLEASE NO SURF OR BOGGIE BOARDS ALLOWED. Pets, Jewelry, Sweets, Food, Sharp objects, Drinks on wave slide. No braaing, smoking near waterslide.
18. PLEASE NO SHOES
19. Remember to close valve under pond before use.
20. Motor must be place away as far away from waterslide when in use.
21. Safe setup of the waterslide was fully explained to the hirer before waterslide was handed over to the hirer.
