

**JUMPING CASTLE RULES:**

1. A Responsible ADULT 18 years or over to be present at all times when jumping castle is used/deflated (for kids safety)
2. **PLEASE NO:** No face painting, Shoes, Pets ,Jewellery, Water, Sweets, Food Sharp objects, Drinks, Adults on castle.(Max age 13 years on castle)or braaing, smoking near castle
3. No climbing on castle sidewalls nor small children with older children on castle
4. No children to play with the motor or electricity cable/fitting.
5. If deflating all children must exit as suffocation could result.
6. Motor must not get wet. Please put inside if it rains

## INDEMNITY FORM and TERM & CONDITIONS

### Terms & Conditions MUST be read & understood thoroughly.

**A responsible adult 18 years or over must be assigned to supervise the children while the unit is in use. The adult must know all the safety rules and also be the enforcer of these rules. The hirer is responsible for the safety of the children and the care of the equipment.**

### Safety First!!

**To make the most from our inflatable units and to ensure the safety of its users, make sure you follow the important safety rules**

#### **\*To avoid injury to persons or damage to equipment:**

**UNDER NO CIRCUMSTANCES** is footwear (shoes) of any sort, jewellery and any other **sharp objects** that might puncture the inflatable unit be used

Castles are designed for no more than **8 children at one time.**

**Climbing on castle sidewalls NOT permitted.** (Kids could fall off and be injured also Jumping castle could tear)

**UNDER NO CIRCUMSTANCES** are **ANY pets (especially dogs)** allowed on or near equipment at ANY time.

**NO food, eating utensils, drinks, sweets, lollipops, allowed** on the jumping castle.

**Age limit for castle - UP TO 13. Please no adults.**

**No braaing, smoking** near jumping castle

**No children to play with the motor or electricity cable/fitting.**

**UNDER NO CIRCUMSTANCES** is the **use of water hoses on jumping castle permitted.** This could damage equipment or cause injury to person(s). (Kids slip bump into each other)

**Individuals with head, neck, back** or other muscular-skeletal injuries or disabilities, pregnant women, small infants and others who may be susceptible to injury from falls, bumps or bouncing and are not permitted in the inflatable unit at any time

All / Any Equipment **MUST** not be removed from setup location. All pegs, tie downs, restraints, ropes etc must remain in place, if removed this could pose as an extreme danger. Caution Keep unit away from swimming pools

Deflating of castle is strictly forbidden other than to cease activities. (Making sure ALL person(s) are clear of equipment).

The Hirer undertakes to ensure that the electrical power supply is well earthed and the earth leakage is in full working condition.

Castle to be on a flat surface preferably grass and not scraping a tree or wall. Sticks and rocks must be cleared from the Area

If wind blows too strongly (branches off trees start swaying too much) for safety sake cease using jumping castle.

**Motor must not get wet.** In case of rain or bad weather, all children should exit the inflatable unit and the motor should be turned off and stored indoors

If power to the inflatable unit is lost (power failure) ensure all children leave the inflatable unit until power is restored and unit is fully inflated again

The customer will be liable for any damage/theft of the equipment whilst in their care. All damages incurred to inflatable's or motor while in possession of the hirer will be payable by the hirer

All equipment, jumping castle to be **used at OWN RISK**

By accepting delivery of rented items, customer agrees to all terms and conditions, indemnity shown on this rental contract.

Customer/other person acknowledge that he/she has received in good order all rented items and other goods listed on the contract.

Customer/other person assumes full responsibility for all rented items, including their safe and proper use, operation, maintenance, and return to FUN HOPPERS JUMPING CASTLES Customer is responsible for all loss, damage, or repair.

If customer refuses to return rented items, the customer /other person agrees that FUN HOPPERS JUMPING CASTLES and its agents may take all reasonable actions necessary to recover rented items without prior notice or legal process.

Customer/ other person agrees to pay all reasonable attorney fees and court costs incurred by FUN HOPPERS JUMPING CASTLES in enforcing these terms and conditions.
